VDMA (German Engineering Federation) is the trade association of the German capital goods industry. With more than 3,100 members the association represents almost all major manufacturers of machinery, plant and apparatus in Germany.

The two core tasks of VDMA are the representation of interests to bodies outside the industry and the provision of comprehensive services for its member companies.

As the German machinery and plant construction industry is a very heterogeneous and varie-

gated sector, VDMA unites under its roof 38 industry-specific associations.

Special departments such as Foreign Trade, Business Management Services, Legal Services and Taxation, Statistics and Business Research, provide competent advice and information where questions apply to more than one industry. Furthermore, six Regional Associations maintain close contact to the companies in their respective catchment areas.
